

15. DESCRIPTION OF EQUIPMENT OR PROTECTIVE SYSTEM

The **DANIAMANT LTD L6-Ex and L6A-Ex Emergency Lifejacket Lights** are illuminating lifejacket safety devices designed for use when the wearer enters the water, the difference between the two models is the method in which the unit is activated, the L6-Ex utilises a pull ring whilst the L6A-Ex has a water activated switch.

The equipment comprises of a printed circuit board, lithium battery, light emitting diode and in the case of the L6-Ex a reed switch, the enclosure for the device is comprised of two plastic parts.

The electronics within the housing are encapsulated in epoxy resin.

Intrinsic safety is maintained by the limitation of current, power, inductance and capacitance and the use of specified batteries.
