2. IN CASE THE SPECIFIED REGULATIONS STANDARDS ARE AMENDED DURING THE VALIDITY OF THIS CERTIFICATE, THE PRODUCT MUST BE RE-CERTIFIED BEFORE PLACED ONBOARD VESSELS TO WHICH SUCH AMENDED REGULATIONS OR STANDARDS APPLY; AND
3. EACH UNIT MUST BE MARKED WITH CLEAR PRECISE INSTRUCTIONS FOR SAFE USE, A MEANS OF A BATCH AND LOT NUMBER IS IDENTIFIED, AND THE EXPIRY DATE.

This certificate remains valid until the date stated hereon, unless canceled or revoked by the Authority, which may withdraw this approval at any time for reasons of non-compliance with the applicable regulations referred to in this Certificate of Approval.

It is the responsibility of the manufacturer to notify the Authority of any modifications or changes to the equipment to ensure the continued validity of this certificate.

This Certificate of Accreditation is valid until 10 October 2024 subject to meeting the requirements of the relevant Legislation. This Certificate may be withdrawn, at the discretion of the issuing Authority, for non-compliance.
